<u>VACATION:</u> 6% of gross weekly pay is deducted from each employee and sent to the Vacation Allowance Plan with the monthly benefit contributions.

<u>NEBF</u>: (National Electrical Benefit Fund), your National Pension Plan. Contribution is 3% of Gross Wages and is paid on all Bargaining Unit employees.

Annuity/401K and Local Pension to be paid at the rates listed above.

<u>WORKDAY:</u> Eight (8) continuous hours worked exclusive of a thirty (30) minute lunch between the hours of 5:00 a.m. and 10:00 p.m. shall constitute the normal workday and five (5) consecutive workdays, Monday through Friday, constitute the normal workweek. A workweek of four (4) consecutive ten (10) hour days, Monday through Thursday or Tuesday through Friday may be established, in accordance with Section 3.01.

<u>OVERTIME:</u> Time and one-half shall be paid for the first two (2) hours of work, then the overtime rate shall be double the straight time stockman rate of pay for all work performed on the same shift. The first eight (8) hours worked on Saturday shall be paid at time and one-half. All other overtime shall be paid at the rate of double time, in accordance with Section 3.02.

<u>HOLIDAYS:</u> New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, the day after Thanksgiving Day, and Christmas Day (7). Workers shall be permitted to observe Martin Luther King Jr.'s Birthday as a holiday with no retaliation of any kind by the Employer providing that they notify the Employer at least two (2) days in advance of their intent to do so, in accordance with Section 3.04.
