## Dear Election Judge:

TrueBallot, Inc. was appointed the impartial balloting agency to supervise the conduct of the ballot with respect to the IBEW Local 46 delegate election. The ballots were tabulated on June 25, 2025

The ballot and materials were approved as to form. A total of 5,636 ballots were sent to the general membership. Voters voted via mail. A total of 25 duplicate ballots were sent to members. No voters were added to the list. A total of 48 ballots were returned as undeliverable by the USPS. The balloting period was from May 27, 2025 to June 12, 2025. The United States Post Office in Tukwila, Washington acted as depositor for receipt of all ballots. TrueBallot, Inc. was authorized to act as coordinator during the balloting period, to mail duplicate ballots to any member on authorized request for a duplicate ballot, and to keep a record of all duplicate ballots mailed. Returned mail ballots were collected from the post office and returned to the tally site on June 25, 2025.

A total of 406 ballots were cast by mail. All were registered against the list of eligible voters. Any duplicates or ineligible ballots were removed. A total of 401 mail ballots were removed from their secret ballot envelopes and counted.

After the ballots were registered, the outer envelopes were opened, and ballots were removed. Ballots were optically imaged and processed to obtain the data. Rules were applied to the data to remove void data from the tally. All ballots were audited and corrected as needed.

The results of the balloting are herewith certified and are attached hereto. It is our opinion as the impartial balloting agency that the results of the balloting are true and accurate. The ballots were properly counted. At the end of the counting, all ballots and materials were placed in appropriate containers, sealed, and delivered to the organization. A CD with all the ballot data and ballot images was delivered along with the ballot materials.
